RULES & REGULATIONS CONTRACT AGREEMENT

1. In consideration of an offer to register or otherwise participate in Houston Girls Cotillion (“HGC”), or an event sponsored by HGC, (on behalf of themselves as members, or as the escort of a member, or the parent of a member or escort); each member and her escort, as well as each of their parents and/or legal guardians (“parent(s)”) consent and agree to the terms of these Rules & Regulations, Consent, Waiver & Release of Liability (“Rules”). Such waiver, release, consent and agreement (“Agreement”) shall be effectuated by completing, signing and returning this Class of 2020 Event Rules & Regulations Contract Agreement after full review of the terms of this Agreement. Each minor member and her escort must consent by signing this Class of 2020 Event Rules & Regulations Contract Agreement and each parent must also consent by signing this Class of 2020 Event Rules & Regulations Contract Agreement. Minors may not consent on behalf of their parents. Each section must be initialed by the Member, Member’s Guardian, Escort, and Escort’s Guardian. Each of the party must also sign in agreement to these Rules & Regulations.

2. Attendance at the event is limited to members and their escorts. Attire is a long, floor-length formal gown for members and a full tuxedo for gentlemen escorts. Texas tux, boots and hats of any kind are not allowed. Inappropriate attire will be at the discretion of the Board, and members and escorts with inappropriate attire will not be admitted to the event, and will not be eligible for any refund of monies.

3. No alcohol, tobacco or drugs are allowed at the event. Members and their escorts, and their personal belongings, are subject to search and breathalyzer testing may be required at the discretion of HGC, or security hired by HGC for the event. Any member or escort that engages in unlawful acts or inappropriate behavior will be asked to leave immediately, and the member’s membership will be terminated with no refund.

4. Any member or escort exhibiting unacceptable behavior (under the influence of alcohol, drugs, smoking, fighting, lewd dancing, or foul language) or in the possession of alcohol, drugs or tobacco will not be allowed into the event or will be asked to leave immediately. HGC will attempt to contact a parent or the emergency contact on file for the member or escort but if HGC is unable to contact a parent or the listed emergency contact, the matter will be handed over to the police. If asked to leave, the member will not be eligible for any refund.

5. The parents of each member and each escort accept full responsibility for their minor’s observance of all rules and are responsible for any damage caused directly or indirectly by their minor to the venue, any service provider, and/or any attendee or chaperone at the event.

6. Parking & Transportation: Parking is not available for members and/or escorts, unless arriving with a parent chaperone. Limousines, Party Buses/Van arriving are subject to HPD officer inspection.

7. Lock-in time for the event is 7:30 p.m. until 10:30 p.m. Members and escorts are required to register with the check-in table upon arrival and must arrive by the lock-in time of 7:30 p.m. The parents of any member or escort who has not arrived by the lock-in time will be notified.

8. Prior approval from the HGC Board must be obtained for any late arrivals or early departures and the member and escort must check-in and/or check-out with an HGC representative.

9. Members and escorts will not be admitted to the event unless HGC has received complete registration for the member and escort, and this initialed and signed event Reply Contract acknowledging that the member, her escort and each of their parents agree to the terms of this Agreement.

10. Backpacks, oversized purses, and overnight bags are not allowed. Coats, shoes and purses must be checked but HGC is not responsible for any damage or loss relating thereto.

11. Failure to comply with the terms of this Agreement is grounds for dismissal from the event without any refund.

12. HGC is an organization of volunteers. In consideration of an offer to register or otherwise participate in an event sponsored by HGC (on behalf of themselves as members, or as the escort of a member or the parent of a member or escort); each member, escort, and parent agrees, for themselves and for and on behalf of their minors, to waive, release and hold HGC, its members, Board and volunteers (collectively "HGC") harmless from any and all damages, liabilities, causes of action, claims, and losses whatsoever arising as a result of negligence by HGC in connection with the organization or the event. Each Member, escort, and parent further agrees to indemnify HGC relating to any losses, damages, claims, or causes of action directly or indirectly relating to their, or their minor's, participation in HGC, including, but not limited to, the event, and any activities prior to and after the event.

13. Participation in the event is voluntary and the member, escort, and parents assume all risk associated therewith. HGC is not responsible for the safety or conduct of any member or escort.

14. The Board of the Houston Girls Cotillion, Class 2020 reserves full discretion in admitting and dismissing members and escorts.

15. Members may attend the event with or without an escort.

16. Member, escort and parents each acknowledge that there will be photographs and video taken during the event and each consent and agree to the use of their photos and video on the website of HGC or any photographer designated by HGC as the event photographer. HGC is not responsible for the content of the photos or video and any complaints related thereto should be directed to the photographer. This consent and release is without further compensation for the use of such photos and video.
